



Committee – Highways Department - Reconstitution of Technical Committee for scrutinizing the proposals relating to Revised Administrative Sanction – Orders – Issued.

ORDER:-

In the Government Order first read above, the Government have constituted a Technical Committee for Scrutiny/review of Revised Administrative Sanction proposals relating to Highways Department for one year from the date of issue of the order. In the Government Order second read above, the Technical Committee for Revised Administrative Sanction was last reconstituted for a further period of two years and further revised as per the Government letter third read above.

2. In the letter fourth read above, the Director General has requested the Government to reconstitute the Committee for a further period of two years.

3. The Government have examined the proposal of the Director General and decided to accept the same. Accordingly the Government direct that the Technical Committee be reconstituted with the following members for the scrutiny/review of the proposals relating to Revised Administrative Sanction in Highways Department for a period of two years from the date of issue of the order.

4. The terms of reference of the Committee shall be the same as in the Government order first read above.

5. The members of the committee will be eligible for Travelling Allowance and Dearness Allowance as first class committee and a sitting fee of Rs.1,000/- (Rupees One Thousand Only) per day of sitting.
